Proposed New Changes to NWT Structure - Jan 2025

We are looking at some changes to the NWT structure. Many Trail Associations in Minnesota have gone this route in the last few years. It eliminates members from the association and moves all members to its associated Clubs. NWT is still operating under bylaws written in the '90s. Since we are looking at upgrading those now makes it a perfect time to look at this also.

Advantages to NWT

NWT would no longer need to collect and pay Dues to MNUSA. No more rosters.

NWT would no longer collect \$10 per year for dues. No more tracking who has paid and who has not.

This would eliminate all member liabilities for NWT

Disadvantages to NWT

NWT would not be collecting \$1000 to \$1500 per year for memberships

Advantages for our clubs

Clubs would still be able to collect \$10 from members for their needs or could reduce dues by \$10 for each member, their choice.

Disadvantages to clubs

Clubs would have to collect and pay MNUSA dues from their members and maintain a roster.

2 members, of the club's designation from each club, would be needed to attend board meeting for NWT. This gives clubs a say on what NWT does and spends \$ on.

Any possible Member liabilities would shift to the clubs. NWT would still maintain and pay liability insurance for the trails and our clubs.

May, Elections and vote on new bylaws change

June, New board, new bylaws take effect

Other Proposed Changes

Trail Administrator. The Trail Administrator shall act as liaison to all government officials on behalf of the NORTHWEST TRAILS

ASSOCIATION as required by any grants or government contracts. The Trail Administrator shall delegate duties to other members of the Board of Directors and Club Trail Coordinators to resolve landowner disputes or concerns, and as required by grants or government contracts. The Trail Administrator will be elected by general

Club Trail Maintenance Coordinators. Each Club Trail Maintenance Coordinator shall supervise and be primarily responsible for the coordination of all trail grooming activities, including but not limited to: scheduling operators, maintaining trail groomers, oversee maintenance records and equipment logs, and other maintenance activities. All Trail Maintenance Coordinators will answer to the Trail Administrator and are appointed by each club

Club Trail Captains

membership.

Each club will maintain a list of all trail captains in their club region. Each Club Trail Captain will answer to the Club Trail Maintenance Coordinator. Club Trail Captains should notify the Trail Administrator when Land Owner issues are involved. All Train Captains should be appointed by the Club Trail Maintenance Coordinator.
